# Consultation on admission arrangements for EEEA's schools for 2025

Engage Enrich Excel Academies (EEEA), as the admission authority for all schools within the Multi Academy Trust (MAT), are conducting a **full** consultation on admission arrangements, including proposed changes, for two of the schools within the MAT for September 2025 entry. The Schools are:

- The Cambridge Primary school, Aldershot, Hampshire.
- Ravenscote Junior school, Camberley, Surrey.

Comments are invited on any aspect of the proposed Admissions Policy for the two schools. The proposed Admissions Policy for each school is attached as separate documents. In particular, the proposed changes, if any, from the 2024/5 policies are as follows:

- **The Cambridge Primary School** A split sibling policy to those living within the catchment area and those living outside the catchment area. There is no change to the catchment area.
- **Ravenscote Junior School** No changes are planned. Full Consultation required under the seven years rule as required by Section 1.45 of the School Admission Code 2021.

The consultation will run from Wednesday 15<sup>th</sup> November 2023 to Tuesday 2<sup>nd</sup> Jan 2024. After the closing date, responses will be collated and presented to the Trust board meeting prior to 28<sup>th</sup> Feb 2024.

#### **Reasons and effect of changes**

The school is aware of the increase in popularity of the school both at the initial intake stage and by the number of in year applications.

The school has always wished to be a school serving the local community. The number of dwellings in the locality and within the catchment area is increasing. The demand from those living within the catchment area is increasing and is expected to increase.

The school inherited and continued to work closely with Hampshire's School Admission team in maintaining the catchment area so that it did not affect other schools.

In the admissions criteria priority is given to all siblings regardless of whether they live within the catchment area or not. This is to enable families to keep siblings together at the same school as is the case in most other schools.

However, priority for siblings, particularly those living outside the catchment area, means that children living within the catchment area, some of whom live very close to the school, are being denied places. The trend (see table below) clearly indicates that the non-sibling children living in the catchment area is increasing and expected to increase.

The proposed changes means that over time, priority will be given to those within the catchment area and within this to siblings within the catchment area. Similarly, priority will still be given to sibling within those living outside the catchment area.

Analysis of the entry at YR stage over the last three years shows that by introducing the new criteria all the siblings would have been admitted.

For the Sept 2024 intake, based on school knowledge, there are expected to be 10 siblings outside of the catchment area. This indicates that the number of siblings outside the catchment area is on a declining trajectory so the number affected, if any, will be even less by Sept 2025 intake.

Conversely, the number of non-siblings within the catchment area is increasing.

The additional effect has been on in year applications. Analysis of the data shows that the new criteria will ensure that children living in the catchment area have priority over siblings outside the catchment area. This is fair and reasonable because those parents having siblings and living outside the catchment area, during an in-year application, will have full knowledge when electing to place the first sibling at the school, that second and subsequent siblings will be lower priority.
