CONSULTATION ADMISSIONS ARRANGEMENTS SEPTEMBER 2021

As required by regulations, The Cambridge Primary School, will be conducting a consultation on its proposed admissions arrangements for the school year 2021 – 2022.

PROPOSAL

The Cambridge Primary School, as the admissions authority, is seeking comments on the proposed change.

At present The Cambridge Primary School admissions criteria states that:

Admission Criteria (Present)

If the school is oversubscribed, places will be offered up to the PAN in the following priority order:

1. Looked after children or children who were previously looked after
2. *(For applicants in the normal admission round only)* Children or families who have a serious medical, physical or psychological condition which makes it essential that the child attends The Cambridge Primary School rather than any other. (Appropriate medical or psychological evidence must be provided in support.)
3. Children of staff who have been recruited to fill a vacant post for which there is a demonstrable skill shortage.
4. Children living **in** the catchment area of The Cambridge Primary School who at the time of application have a sibling on the roll of The Cambridge Primary School who will still be on roll at the time of admission.
5. Other children living **in** the catchment area of The Cambridge Primary School.
6. Children living **out** of the catchment area of The Cambridge Primary School who at the time of application have a sibling on the roll of The Cambridge Primary School who will still be on roll at the time of admission.
7. Other children.

1. The removal of criterion 2, (*For applicants in the normal admission round only*) Children or families who have a serious medical, physical or psychological condition which makes it essential that the child attends The Cambridge Primary School rather than any other. (Appropriate medical or psychological evidence must be provided in support.)
2. To ensure that all siblings, regardless of whether they live in the catchment area or out of the catchment area are considered under the 3rd criterion, as below:

Admission Criteria (Proposed)

If the school is oversubscribed, places will be offered up to the PAN in the following priority order:

1. Looked after children or children who were previously looked after (*see (i) in Definitions on admission policy*).
2. Children of staff (*see (ii) in Definitions on admission policy*). who have been recruited to fill a vacant post for which there is a demonstrable skill shortage.
3. Siblings (brothers or sisters at the school at the time of admission) (*see (iii) in Definitions on admission policy*)
4. Children living **in** the catchment area of The Cambridge Primary School.
5. All other applicants

The governing body are in favour of the proposal.
